Perustelut:

Kansainvälinen rekisteröinti on sekoitettavissa luokkien 9, 18 ja 28 tavaroiden ja luokan 35 palveluiden "Retail services in connection with the aforementioned goods; advertising, in particular advertising consultancy and planning, consultancy for retailers with regard to advertising in print media, on Internet sites and radio adverts, arranging of advertising, advertising by announcements, shop window dressing, radio, television and cinema advertising, bill-posting, prospectus advertising, direct advertising, advertising on transport vehicles, leafleting and distribution of printed advertising materials and consumer magazines, dealer and product promotion, tie-in promotion, distribution of goods for advertising purposes, distribution of advertising gifts and other give-away articles, advertising design; marketing, in particular market research, market analysis, marketing consultancy, development of marketing plans for service providers, commercial companies, service cooperation companies and commercial cooperation companies; all the aforesaid services in connection with footwear, sporting articles and leatherware" sekä luokan 41 palveluiden "conducting sports seminars, arranging sports competitions; all the aforesaid services in connection with footwear, sporting articles and leatherware" osalta toiminimeen Sport 2000 Oy, jonka toimiala kattaa samoja ja samankaltaisia tavaroita ja palveluita kuin edellä mainitut kansainvälisen rekisteröinnin tavarat ja palvelut.

Toiminimen toimiala kattaa mm. vapaa-aikaan liittyvien välineiden tuottamista ja markkinointia, näyttelyiden ja vapaa-ajan tapahtumien järjestämistä sekä muovituotteiden valmistusta ja myymistä.

Kansainvälinen rekisteröinti muodostuu ympyrässä olevista kahdesta väristä ja tekstistä SPORT 2000. Vaikka sanat sport ja 2000 sinänsä ovat erottamiskyvyltään heikkoja elementtejä, muodostavat ne kokonaisuutena merkistä vahvimmin mieleen jäävän osan. Kun toiminimi muodostuu vain tekstistä Sport 2000 ja yhtiötunnuksesta Oy, on kansainvälisen rekisteröinnin katsottava olevan kokonaisuutenakin arvioiden sekoitettavissa toiminimeen.
